Why consider a Pre-payment scheme?

In the past it was not possible to make, and pay for, funeral arrangements in advance. Insurance policies were traditionally used for this purpose, but they can never guarantee to cover the full cost of a funeral, irrespective of when it may take place. Our scheme does not rely upon the hope that funds will grow and cover those future expenses. It instead guarantees that all costs have been paid. An additional benefit is the peace of mind that comes with knowing your arrangements are in place and family members will not have to make difficult decisions or face unexpected expenses at a time of bereavement.

Why Freeman Brothers?

Freeman Brothers has been established in the Horsham area for over 160 years. We take pride in offering a personal service in a profession that is becoming increasingly swamped by national and multinational organisations. Unlike those of most of our competitors, we offer a guarantee that both our charges, and those Third-party costs included in the plan, are fully covered. There is therefore no uncertainty about what will be covered when the time comes, and no extra amounts to be paid.

How the Scheme works

On the opposite page you will see what is included in our five tiers, and their respective prices.

The **Basic Scheme** is for a Cremation service at The Surrey and Sussex Crematorium or Worthing Crematorium, where Freeman Brothers chooses the date and time. Further, we reserve the right to choose at which of the two crematoria the service will take place.

The **Simple Scheme** is for a Cremation service at The Surrey and Sussex Crematorium or Worthing Crematorium, arranged at a mutually convenient time, as are all our plans with the exception of the Basic plan.

The **Standard Scheme** is for a cremation service at any local Crematorium.

The **Principal** and **Supreme Schemes** are suitable for a burial or cremation, with a service in a place of worship prior, if required.

All the schemes include giving help and advice to relatives, bringing the Deceased into our Chapel of Rest and caring for them there prior to the funeral, the necessary staff and the hearse for the funeral and a coffin as stated. We will also pay the required charges to third parties. We guarantee that, whatever your scheme covers, we will never ask for further payments towards those costs.* At the time of need we can of course provide additional services which will be charged at the prevailing rate. This excludes the Basic plan, where the ability to add items at the time of death will be at our discretion.

*The only thing our plans specifically exclude is the purchase of a plot, if applicable. This must be done directly with the relevant Burial Authority either prior to, or at the time of, the funeral.
